6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

Wipe up with absorbent (clean rag or paper towels). Wear protective equipment to prevent skin and eye contamination. Avoid inhalation of vapours or dust. Collect and seal in properly labelled containers or drums for disposal.

LARGE SPILLS

Clear area of all unprotected personnel. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and the inhalation of vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand, or other inert material). Collect and seal in properly labelled containers or drums for disposal. If contamination of crops, sewers or waterways has occurred advise local emergency services.

7. HANDLING AND STORAGE

Handling: Avoid eye contact and repeated or prolonged skin contact. Avoid inhalation of vapour, mist, or aerosols. Keep containers securely sealed when not in use, Use in a well-ventilated area. Always wash hands with soap and water after handling.
